

## New Connections Legal Permissions & Consents Process Monthly Performance Report: February 2024

We measure performance of the legal permissions and consents process relating to new connections at two stages:

- 1. When a matter is with us to contact landowners, local authorities etc and progress negotiations, i.e. before we have instructed our lawyers.
- 2. When terms have been agreed with landowners or our customers for the purchase of land or rights over land and we have instructed our solicitors, Geldards, to complete the legal transaction.

We measure performance at both stages and publish monthly reports to our customers. This report provides information on the performance of our own staff, that is to say the first stage above. Geldards' monthly performance in respect of the second stage is reported separately.

In consultation with our customers we have agreed a range of performance measures for our own activities across a range of transaction types. Each transaction type comprises a series of activities which are appropriate to the transaction type and there are targets for these activities. We have agreed with our customers <u>an overall target of 80% compliance</u> across all measures.
